

# 2021-2022 Alumni Outcomes for Bachelor and Associate Degree Recipients Summer and Fall (2021) and Spring (2022)

# Office of Academic Affairs Assessment and Quality Initiatives

#### Survey Administration Timeline

The Alumni Survey was sent to 2021-2022 graduates between six to twelve months <u>after</u> graduation. The Graduation Survey was sent to students approximately six weeks <u>before</u> graduation. Responses from graduation surveys are included only for students who reported plans for full- or part-time employment, military service, specific volunteer service, or further education they would pursue after graduation. In the case of further education, respondents to the graduation survey had to provide some specific information about their plans. If respondents completed both the Alumni and Graduation surveys, responses from the Alumni surveys were used in this analysis.

# **Responses Rates by College**





Of the 308 graduates for whom who have full-time employment salary data, 95 (31%) reported earning \$40,000 or less annually, with 73 (24%) earning between \$40,001 and \$50,000. The remaining 140 (45%) of respondents earned more than \$50,000 annually.





#### 5. First Year Bonus

Forty-eight respondents indicated that they received first-year bonuses. Amounts reported were as follows: College of Arts and Media - \$2,000; Regents' Bachelor of Arts - \$1,200; Lewis College of Business - \$200, \$200, \$2,000, \$2,000, \$2,000, \$4,000, \$5,000, \$7,500, \$3,000 to \$5,000; College of Education and Professional Development - \$43,000; College of Engineering and Computer Sciences - \$3,000, \$5,000, \$7,000, \$7,500, 20% of salary, \$30 X hours of overtime; College of Health Professions - \$1,000, \$1,500, \$1,500, \$2,500, \$3,000, \$3,000, \$5,000, \$5,000, \$5,000, \$5,000, \$5,000, \$5,000, \$5,000, \$5,000, \$5,000, \$6,000, \$7,500, \$10,000, \$10,000, \$10,000, \$10,000, \$10,000, \$10,000, \$12,000, \$45,000, 3% raise; College of Liberal Arts - \$150, \$1,200, \$1,200, \$1,700; College of Science - \$1,600, \$5,000, \$11,620, 3%.
