arshall University invites inquiries, nominations, and applications in the search for its 38th president. The appointment will follow the presidency of Jerome A. Gilbert, Ph.D. President Gilbert will leave a legacy of success and has served with a passion for the community and a deep commitment to Marshall's students, faculty, and staff.

Marshall University seeks candidates of the highest caliber befitting both the history and spirit of excellence that characterize Marshall University. Finalists for the position will come to campus and visit with the board, the campus community, and the public.

Marshall University is a public comprehensive research university with a rich history as one of the oldest institutions of higher learning in West Virginia. Marshall advances the public good through innovative, accredited educational programs. The university is located in Huntington, West Virginia, with additional campuses in South Charleston, Point Pleasant, Teays Valley, and Beckley. Marshall is classified as an R2 institution, Carnegie Doctoral University: High Research Activity. The university enrolls 11,962 students: 8,776 undergraduate, 2,515 graduate, and 671 first professional. The university achieved Doctoral University - High Research Activity - R2 in 2018 and offers more than 150 undergraduate, graduate, and professional degree programs organized into seven academic colleges and two schools. As the Thundering Herd, the university participates in the NCAA Division I, Conference USA. Marshall University is situated in a region of great natural beauty; Huntington is nestled in the heart of the Appalachian Mountain region, with the Ohio River creating the perimeter of the city.

#### **History and Culture**

One of West Virginia's oldest public institutions of higher education and its second largest, the university was named after Chief Justice John Marshall, Fourth Justice of the United States and definer of the Constitution, and was founded as Marshall Academy in 1837. It was designated Marshall College in 1858 and attained university status in 1961.

Marshall's distinct brand and traditions are steadfast and well-ingrained in the university's Thundering Herd faithful. Marshall is a welcoming and resilient institution that reflects the Appalachian region that it serves. That culture was further defined and galvanized by the 1970 plane crash, where the lives of 75 people were lost in the single worst air tragedy in NCAA history. Among the losses were nearly the entire Marshall University football team, coaches, flight crew, numerous fans, and supporters. This event is commemorated on campus every year during a memorial service at the Memorial Fountain. In 2006, the motion picture We Are Marshall chronicled the story of "The Crash."

### **STUDENTS**

Marshall University is an anchor institution in southern West Virginia that draws its 11,962 students from 49 states and 56 countries. A degree from Marshall is a transformational achievement that changes lives and inspires extraordinary futures. Marshall students benefit from the university's small class sizes, active and engaged faculty classroom instruction, the availability of intensive advising paired with exceptional student success resources, modern facilities, and robust extracurricular programming. The **average ACT is 23** and the **average incoming freshman GPA is 3.64**. The first to second year retention rate of first-time freshmen in 2019-20 was 77%. A **substantial number of students are first-generation college students** requiring significant financial assistance; **37.8 percent of undergraduate students received Pell Grants** in fall 2019.

Beyond the classroom, Marshall is home to 230 recognized student organizations and 20 fraternities and sororities, which contribute to a deep campus life and a vast range of extracurricular experiences for students. Student services include career counseling, resource and writing centers, a women's and gender center, veteran and military support, and counseling and health services. To accommodate students, Marshall has 10 residence halls, a student center and food court, and two dining halls.

## THE SOCIETY OF YEAGER SCHOLARS

The Society of Yeager Scholars is a prestigious academic and leadership program housed with the Honors College. This program provides scholarships to individuals who are considered exceptional in their studies as well as in leadership roles. The benefits of the scholarship apply for up to eight semesters of undergraduate enrollment. Yeager Scholars are involved in leadership roles for organizations both on the campus of Marshall University and in the community. An important goal of this program is to provide an experience that will develop highly motivated leaders for the next generation.

### **FACULTY AND STAFF**

Marshall's student-centered research mission is embodied by the university's accomplished and committed faculty and staff. With an undergraduate student/faculty ratio of 18:1 and average class size of 20, the faculty forge close relationships with their students as they work to make a profound difference in their students' lives, particularly for those who arrive at Marshall with great potential but lacking some preparation. Through their students and their research—and with critical support from the university's talented and engaged staff—Marshall's faculty positively contribute to the region and beyond. Marshall employs more than 1,000 faculty members (more than 800 full-time), and, including the School of Medicine, 88 percent of full-time faculty hold a Ph.D. or terminal degree in their fields. More than 800 staff support the operation of the university.

### **GOVERNANCE**

Marshall University is a **public institution** of the State of West Virginia. The university is governed by **a 16-member Board of Governors**. Thirteen are lay members appointed by the governor, by and with the consent of the West Virginia Senate. The other three members represent the faculty, student body, and classified employees, and are duly elected to the board by their respective constituencies. The board determines, controls, supervises, and **oversees the financial, business, and educational policies and affairs of the Institution**. The board also develops a master plan, approves the Institution's annual budget, reviews and controls all academic programs offered at the Institution, and approves tuition rates and applicable student fees.

The West Virginia Higher Education Policy Commission oversees the public policy agenda for West Virginia's four-year colleges and universities.

## **ACADEMICS**

Building on its historic strengths in the undergraduate liberal arts, Marshall University has developed its graduate programs to include master's, specialist, and doctoral degrees. Marshall offers **57 baccalaureate**, **2 associate degree**, **52 master's degree**, **2 education specialist degree**, **4 doctoral degree**, **and 3 first professional degree programs**. Through these additional graduate programs, Marshall prepares many of the doctors, physical therapists, and pharmacists who provide health care across its tri-state region and beyond. Additional recent points of pride in Academic Affairs include:

- First professional **Master of Athletic Training degree** in West Virginia (2016)
- New aviation programs in **Commercial Pilot Fixed Wing (B.S.)** and **Aviation Maintenance (A.A.S.)** starting in 2021 and 2022, respectively
- One of only three accredited **Health Informatics master's degree** programs in the country
- Nationally recognized graduate **DNA and Digital Forensics** programs
- A \$1.8 million gift from the Encova Foundation of West Virginia for the auditorium in the **new Lewis College of Business building**, home of the Brad D. Smith Schools of Business



## FOLLOWING SCHOOLS AND COLLEGES

The mission of the *Lewis College of Business* is to be a leading state institution for the education of business students, and a contributor to the region's economic development. The COB is dedicated to graduating individuals who possess the communication, critical thinking, and problem-solving skills necessary to meet the Tri-State area's needs for the demands of the global marketplace.

### The <u>College of Education and Professional Development</u>

continues to prepare teachers and other professional educators, including counselors, principals, supervisors, and superintendents. It also provides continuing education opportunities for professional educators and directs all teacher education programs at Marshall University.

The <u>College of Arts and Media</u> is dedicated to the discovery, application, transmission, and advancement of knowledge in arts and in media. Through its rich and varied public programs, the college informs and enhances the lives of students and the wider community. Students are prepared for productive lives as global citizens and 21st century leaders through their professions and in their communities.

The <u>College of Health Professions</u> is committed to offering quality undergraduate and graduate nursing and health professions education. The focus of the College of Health Professions is upon being interactive with the community, including rural and underserved areas, and responding to contemporary and future needs of society, nursing, and the health professions.

The *College of Engineering and Computer Sciences* builds on combined traditions of student-focused education, entrepreneurship, and funded research and service emphasis. CECS provides education when and where needed, incorporating technology-enhanced methods, by full-time, dedicated faculty complemented by expert adjunct faculty from industry and government.





The <u>College of Liberal Arts</u> has the responsibility to preserve, transmit, interpret, and create knowledge in an environment of free inquiry and expression. COLA provides instruction that forms the core of the undergraduate curriculum for all Marshall University students so they may think critically and imaginatively, communicate effectively, and understand various dimensions of human experience.

Scientific and technologically trained people are essential to the nation's health and prosperity in a rapidly expanding global economy. Undergraduate students in the *College of Science* receive a broad education conducive to pursuing a wide range of career options. Special emphasis is placed on experiential learning through participation in activities such as undergraduate research and internships.

Established in 1976, the *Joan C. Edwards* School of Medicine quickly developed a reputation for providing students with a high-quality, hands-on medical education delivered in an atmosphere of caring and respect. Since that time, the school has also dramatically expanded its scope of research and clinical services, giving students an energized learning environment in which to become physicians.

The <u>School of Pharmacy</u> educates compassionate, ethical, and competent students to become innovative thinkers, problem solvers, and the future leaders in pharmacy. To accomplish these goals, the school has developed a curriculum that fuses local practice standards and vision to the evolving trends within the discipline.







Additional units in Academic Affairs include:

The *Graduate Studies* program offers 48 master's degrees, 7 doctoral degrees, 2 education specialist degrees, and 33 certificate programs, including the new Pharmacy and Physical Therapy doctoral programs. Graduate Studies is committed to the intellectual, professional, and personal growth of students through the delivery of high-quality education at convenient times and places.

The <u>Honors College</u> fosters academic excellence in a community of learners whose undergraduate education is enhanced through innovative teaching and learning, an engaging interdisciplinary curriculum, creative and critical inquiry with talented faculty, and diverse leadership and service opportunities.


The <u>Office of Outreach and Continuing Studies</u> provides the citizens of West Virginia with increased access to college-level courses and programs with special emphasis on regional centers and adult learners.

University College extends this mission to all Marshall students by providing a broad range of academic services and transitional support programs.

Marshall University has a thriving *Online Learning* program that currently includes 3 doctorates, 20 master's degrees, and 8 bachelor's degrees that can be obtained solely by technological means in asynchronous or hybrid formats. With the number of distance students growing annually, Academic Affairs has adapted student support to ensure that this population receives a full array of services similar to those available on campus.

There are great opportunities for all types of students—undergraduate, graduate, adult degree completion, and online—at Marshall's locations in **South Charleston, Point Pleasant, Teays Valley and Beckley.** The faculty and staff on these campuses are looking forward to working with the next president help the institution further benefit from these resources.

## **ATHLETICS**

The university's Thundering Herd athletic teams compete in **16 NCAA Division I intercollegiate sports**: 10 women's (Basketball, Cheerleading, Cross Country, Golf, Soccer, Softball, Swimming and Diving, Tennis, Track and Field, and Volleyball), and six men's (Baseball, Basketball, Cross Country, Football, Golf, and Soccer), all competing in **Conference USA**.

Especially noteworthy, Thundering Herd football has led Conference USA in total wins since 2014. In pre-pandemic 2018-2019, four Thundering Herd teams reached postseason play for the first time in the same year: football, men's and women's basketball, and softball. During the 2020 season, Marshall football defeated a nationally ranked team in Huntington for the first time in 44 years, producing its highest national ranking since 1999. Further, men's basketball had unprecedented success in 2017-2018, winning the Conference USA Tournament Championship, earning its first-ever NCAA appearance, and garnering its initial tournament victory.

The exclamation point on Marshall's recent competitive success was men's soccer bringing home the 2020 NCAA College Cup Championship trophy following an amazing run in the Division I Soccer Tournament. This is Marshall's first national championship ever at the Division I level.

Thundering Herd Athletics also has distinguished itself academically, with the past three semesters producing the best academic results in Marshall history. A sign of Marshall's commitment to the health, safety, wellbeing, and performance of its 550 student-athletes is the **Chris Cline Indoor Athletic Facility**, which includes the state-of-the-art **Marshall Sports Medicine Institute** and the **Buck Harless Student-Athlete Academic Center**.

### **COMMUNITY**

With the main campus located in Huntington, West Virginia, Marshall is situated in the tri-state region bordering Kentucky and Ohio, with a **population of 365,000 in the Huntington-Ashland-Ironton metropolitan area**.

Huntington is 50 minutes west of the state capital in Charleston and offers many amenities, including a **symphony orchestra**, **a museum of fine arts**, **and an artists series**. In 2012, the American Planning Association named the city's 100-acre-plus Ritter Park one of the country's 10 Great Public Spaces. Huntington also features **movie theaters**, **a pedestrian trail system**, **shopping**, **fine restaurants**, **public libraries**, **and excellent medical facilities**.

Although Huntington is only a few hours' drive from major metropolitan areas, West Virginia's population density is considerably less than the national average and the state is considered one of the nation's safest. The cost of living here is, on average, lower than the rest of the country.

West Virginia is known as the **outdoor recreation capital of the eastern U.S.**, with easy access from Huntington to skiing and snowboarding, whitewater rafting, camping, zip lining, rock climbing, and mountain biking.

The relationship between the university and Huntington is extraordinarily positive and mutually beneficial. Marshall serves as a culture center, while also playing a major role in rural health care delivery, improvement of elementary and secondary education, and regional economic development.

Marshall's **economic impact in the region is estimated at more than \$1.5 billion annually**—a 20:1 return on public dollars invested in the university.

## **ADVANCEMENT**

With the final stages of the \$150 million Marshall Rises comprehensive campaign underway, Marshall is working with its alumni and friends to ensure the university rises to the next level for the betterment of its students, faculty, staff, region, and state while reinforcing a culture of philanthropy. Total fundraising this year will exceed \$25 million and the university's overall endowment has increased more than 15 percent over the past several years. In this time, Marshall has grown its population of active alumni and friends with one-third of all major gifts coming from new donors. Through this success, Marshall has received a 44 percent increase in private scholarships, which have allowed for the addition of more than 500 new scholarship recipients.

The Marshall University Foundation Inc. has been a key aspect of this success. The foundation was chartered on January 3, 1947, as an independent non-profit organization to receive, invest, administer, and disburse private resources in behalf of Marshall University. Gifts to the foundation add a margin of excellence over and above the appropriate level of state support and are not intended to replace state funds. The foundation plays a crucial role in providing the support critical to the continuing success of a nationally prominent university. The foundation is dedicated to providing this service in a professional and personal spirit of respect, honesty, cooperation and goodwill for the benefit of the university.


Marshall's alumni have also been key in these efforts. The university boasts a loyal and **active alumni population**, 44.5 percent of whom reside in West Virginia and make key contributions to the state's economy and civic life. Marshall's alumni have gone on to lead Fortune 500 companies, win Pulitzer Prizes, and become captains of industry, science, education, and the arts.

## **RESEARCH**

Marshall has seen **exceptional growth in research funding** in recent years, from \$23 million in 2015 to \$49.6 million now. The university is developing collaborative interdisciplinary research clusters in biomedicine/biotechnology, transportation technology/logistics, engineering, advanced manufacturing, the physical sciences, and the liberal arts. Marshall is a leader in advanced, high-performance computing and Internet2® connectivity, positioning the university to partner and compete globally.

The Marshall University Research Corporation (MURC) is committed to an active, growing and successful research enterprise that will help address today's challenges, improve the quality of life in the community and provide an engine for economic development. A not-for-profit corporation, the MURC delivers services like pre-award grant and contract development and post-award grant administration to members of the university community.

In addition to the MURC, the <u>Marshall Institute for Interdisciplinary Research</u> acts as another key vehicle to advancing regional economic development. The institute affords companies the opportunity to develop and mature promising new technologies and products within the university environment. Research is directed with licensable endpoints in mind and corporate partners play important roles in selecting and developing projects that have commercial potential.



## **LEADERSHIP AGENDA**

The 38th president of Marshall University will join a vibrant and resilient campus community that is prepared to navigate the shifting landscape of higher education and innovate in service to the Appalachian region that houses it. With increasing national visibility through new academic programs, growing research, and championship athletics, the campus is eager to be joined by a leader with a keen sense of innovation, mission, and optimism. The president will be a collaborative individual who can maintain the welcoming and student-friendly nature of the institution while proudly representing Marshall's strong institutional identity in Huntington, the Tri-State region, and beyond.

## Key opportunities for leadership for the next president include the following:

Capitalize on recent success and envision the future: With a newly achieved high-research designation, expanded graduate offerings, state-of-the-art additions to campus facilities, national athletic successes, and a highly successful comprehensive campaign, the next president of Marshall University will find a firm foundation on which to plan the next decade of the institution's history. As the pandemic ends and higher education moves into an increasingly uncertain future, the university will require visionary leadership to seize the campus's momentum and continue to build the institution's resource base, research capacities, teaching excellence, and national visibility.

Identify new pipelines for resources and enrollment: As the central institution of higher education in southern West Virginia, Marshall University recruits students heavily from this region. With a declining college-age population, Marshall's enrollment has declined in recent years. The university has effectively identified new funding sources to address this demographic challenge, and the next president will need to continue and expand this work. The president will also need to increase the regional college-going rate by targeting area school and first-generation and nontraditional students while building a broader enrollment model utilizing Marshall's attractive campus and region, a strong value proposition for students, and increasing expertise in remote and hybrid instructional capabilities. The president will be the primary face of the institution with its growing major donor population and in interactions with the state legislature.

**Leverage institutional strengths to address regional challenges**: The next president will need to embrace not only Marshall's campus community, but its Appalachian home.

By knowing the institution's strengths and embracing them, including the tenacity and can-do culture of the region, the president can lead Marshall to develop nationally renowned programs through interdisciplinary collaboration that speak to the challenges facing the region, which include poverty, a brain drain that leads many talented young people to find jobs outside of the region, and deep public health challenges, including the national opioid epidemic. Marshall's campus community has been on the front lines in combatting these issues and could serve as a national model and source of expertise on these societal challenges, while creating programs for new and emerging employment opportunities that keep talent in the state and region. The "We are Marshall" rallying cry speaks to the institution's deep sense of place and community, incredible town-gown relations, and the need to embody its public educational and research mission to lead in difficult times.

**Enhance student success**: Marshall's faculty are engaged teacher-scholars who place a strong emphasis on the classroom experience, which reflects the university's student-centered nature. The next president will need to provide the structures and experiences for students to achieve their highest levels of success by identifying their needs, preparedness, and demographics. Marshall's student body is rich in first-generation students and many of its undergraduates arrive with immense potential but lacking some key preparation for the demands of a university environment. The success and development of all of Marshall's students is central to the mission and values of the university community, and the next president will need to vigorously and creatively pursue this goal.



## The President's House

Historically known as the Campbell-**Staats House**, the Marshall University President's House sits at 1040 13th Avenue in Huntington. Originally completed by W.A. Robinson in 1923 for attorney and one-time Huntington mayor Charles Campbell, the home was designed by the Huntington architectural firm of Sidney L. and R.L. Day as a replica of Mount Vernon in a combination of neoclassical and Greek Revival. Today, the 11,710 square-foot home is listed on the National Register of Historic Places as part of the Ritter Park Historic District and in 2015 was updated in a manner that retained the historic nature of the structure.

The grounds and first floor are used for official university events and to entertain guests of the university. The president's family resides on the second floor.







## Requirements and Preferred Qualifications of the Next President

The next president of Marshall University must possess a degree awarded by an accredited college or university appropriate to their professional background and leadership experience, as well as a progressive record of executive level management and success that has prepared this individual to be a visionary leader for a complex organization.

The ideal candidate for the presidency of Marshall University will have many of the following characteristics and attributes:

- A readiness to act as a primary spokesperson for Marshall, who can effectively
  represent the university and make the case for resources with outside interests and
  allies, including prospective donors, state policymakers, corporate partners, alumni,
  foundations, and other stakeholders.
- The ability to appreciate and maintain key elements of Marshall's history, traditions, and culture at a time of immense change in higher education, while embracing the region it serves, and moving the university forward to new levels of success and collaboration with institutional stakeholders.
- A demonstrated ability to manage the fiscal resources of a complex organization with a commitment to maintain and enhance the fiscal soundness of the university.
- An authentic, engaging, high-integrity individual with the ability to work effectively with all members of the university community to foster growth and development, while building positive relationships with a wide range of local and regional partners to advance Marshall.
- The ability to work effectively with a governing board to determine policy and direction and to provide a voice for that direction to the university community, the region, and beyond.
- A readiness to operate transparently in a shared governance environment and an understanding of the roles and privileges of faculty and staff in furthering the accomplishments and reach of the university.
- A demonstrated commitment to equity and diversity and to creating a welcoming, inclusive environment.
